VETERANS DIVISION: Veterans of any branch of the U.S. Armed Forces,

APPRENTICE DIVISION: Active duty Grades E-1 through E-3 in all branches of the U.S. Armed Forces. Annual dues are \$20.

INTERNATIONAL AUXILIARY: Spouses/former spouses, widows/widowers, and family members 18 years of age or older of enlisted members whether active duty, separated, veteran, Reserve or National Guard, in Grades E-1 through E-9.

WHO CAN JOIN?

NCOA SCHOLARSHIP FUND: Scholarships are awarded to children and spouses of NCOA members. These are non-repayable and are renewable for upto 3 years after the initial grant.

NCOA BETTSY ROSS EDUCATIONAL FUND: Provides grants to memebers of the International Auxilliary wanting to take classes/courses to improve their employable skills.

NCOA DISASTER RELIEF FUND: Provides relief for immediate disaster-related needs to military members and their families who suffer losses as a result of natural disasters such as hurricanes, fires, floods, earthquakes, etc.
